Revised Order

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. And whereas, the Sadguru Swami Vidnyanand Bahuuddeshiya Shikshan Prasarak Mandal Sanchalit, Baliramdada Bansode Shiskhan Shastra Mahavidyalaya, At. - Post. Chale, Tal. Pandharpur, Solapur, Maharashtra by affidavit dt. 14.01.2015 has consented to come under new Regulations and sought for two basic units in B.Ed., which require additional facilities.

3. And whereas, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,

- I. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- IV. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.

4. Now therefore, in the light of the above and in accordance with the <u>NCTE Regulations, 2014, the</u> <u>Western Regional Committee (NCTE) hereby issues the revised recognition order to</u> the Sadguru Swami Vidnyanand Bahuuddeshiya Shikshan Prasarak Mandal Sanchalit, Baliramdada Bansode Shiskhan Shastra Mahavidyalaya, At. - Post. Chale, Tal. Pandharpur, Solapur, Maharashtra for conducting B.Ed programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.

7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution:
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter:
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information. if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

8. Recognition order no. WRC/5-6/90th/2006/ dt. 28.10.2006 be treated as cancelled from the date of issue of this revised order.

RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely to SADGURU SWAMI VIDNYANAND BAHU-UDDESHIYA SHIKSHAN PRASARAK MANDAL BALIRAMDADA BANSODE SHIKSHAN SHASTRA MAHAVIDYALAYA, AT POST-CHALE, TAL-SANCHALIT, PANDHARPUR, SOLAPUR, MAHARASHTRA under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. course (100 Intake) vide order No. APW02801/123362/WRC/5-6/90/2006/12000 dated 28.10.2006.

2. AND WHEREAS, Revised Recognition order was issued to SADGURU SWAMI VIDNYANAND BAHU-UDDESHIYA SHIKSHAN PRASARAK MANDAL SANCHALIT, BALIRAMDADA BANSODE SHIKSHAN SHASTRA MAHAVIDYALAYA, AT POST-CHALE, TAL-PANDHARPUR, SOLAPUR, MAHARASHTRA vide order No. F.No WRC/APW02801/123362/2015/142617-142624 dated 31-05-2015 for B.Ed. of Two Years Duration with an annual intake of 100 students for two basic unit of (50 students) from the academic session 2015-2016.

3. AND WHEREAS, Compliance was not submitted as per regulations 2014.

4. AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "... The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

5. AND WHEREAS, a Show Cause notice was issued to the institution on 10-03-2017 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order.

- 6. AND WHEREAS, the reply of show cause notice was not submitted by the institution.
- 7. AND WHEREAS, the matter was placed in 311th Meeting held on September 25-27, 2019 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"...The Show Cause Notice was issued to the institution vide letter dated 10/03/2017.

The summary of the case submitted reveals that the institution has not submitted reply of the Show Cause Notice.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

- 8. AND WHEREAS, a withdrawal order was issued to the institution on 10-10-2019.
- AND WHEREAS, the institution has filed an Appeal to NCTE Hqrs against withdrawal order dt. 9. 10.10.2019. The Appellate Authority passed an order dt. 02.03.20120 remands back the case.
- 10. AND WHEREAS, the matter was placed in 316TH Meeting held on August 27-28 & 4 September , 2021 of WRC and the Committee decided that.

"... This is RPRO Case Remanded Back by the Appeal Committee

The Committee considered the matter in view of the order of the Appellate Authority, Agenda Note and observed the following:-

- THE SUBMITTED STAFF LIST IS NOT APPROVED BY THE AFFILIATING BODY
- THE INSTITUTION HAS SUBMITTED THE PHOTOCOPY OF NOTARIZED CERTIFIED REGISTERED LAND DOCUMENTS ISSUED BY THE SUB-REGISTRAR GRADE-1 PANDHARPUR, BUT THE SAME IS IN MARATHI LANGUAGE. THE INSTITUTION

- THE INSTITUTION HAS SUBMITTED NON-ENCUMBRANCE CERTIFICATE ISSUED BY AN ADVOCATE. THE NON ENCUMBRANCE CERTIFICATE IS TO BE ISSUED BY THE COMPETENT REVENUE AUTHORITY, GOVT OF MAHARASHTRA.
- THE INSTITUTION HAS SUBMITTED THE LAND USE CERTIFICATE ISSUED BY THE COMPETENT AUTHORITY BUT IN MARATHI LANGUAGE. THE INSTITUTION IS REQUIRED TO SUBMIT THE ENGLISH /HINDI TRANSLATED VERSION DULY NOTARISED
- THE INSTITUITON HAD NOT SUBMITTED THE ORIGINAL FDRS TOWARDS ENDOWMENT AND RESERVE FUND.

In view of the above, the Committee decided that last opportunity be given to the institution to submit documents within 30 days u/s 17 of the NCTE Act for B.Ed course,"

- 11. **AND WHEREAS,** a Final Show Cause Notice was issued to the institution on 21-09-2020 and its reply received on 28.09.2020.
- 12. **AND WHEREAS,** the institution had approach to the Hon'ble High Court of Delhi At New Delhi. W.P. (C) No. 14195/2021 dt. 13.12.2021 the operative part is produced here below:-

"...It has been settled by this Court in an order dt. 08.05.2019 in W.P.(C) 4959/2019 [HICT Shiksha mahavidyalaya vs. National council for Teacher Education & Anr.] and several subsequent orders that, upon remand of a matter to the original authority by the Appellate Committee, the impugned order of the original authority stands quashed. Consequently, by reason of the order of the Appellate Committee dt. 02.03.2020, the status of the petitioner as a recognized institution stands restored and will continue for the academic year 2021-22 and all subsequent years, until and unless a fresh withdrawal order is passed against it.

The writ petition is, therefore, disposed of recording that the withdrawal order passes by the WRC on 10.10.2019 stands quashed, and directing the NCTE to issue an order of restoration of recognition to the petitioner within one week from today. The petitioner is permitted to participate in counselling and admit students for the academic year 2021-22 and for all subsequent years, until and unless a fresh withdrawal order is passed against it. The NCTE is directed to reflect that aforesaid position on its website and to communicate the same to the petitioner's affiliating University, and the concerned State Government within seven days from today.
